

MEMORANDUM OF UNDERSTANDING

Between

**PAHALWAN GURUDEEN PRASIKSHAN MAHAVIDYALAYA, PANARI,
LALITPUR**

And

SAI JYOTI GRAMODOYOG SAMAJ SEWA SAMITI,

Purpose

With the object of promoting their co-operation in academic education and research, PAHALWAN GURUDEEN PRASIKSHAN MAHAVIDYALAYA, PANARI, LALITPUR (PGPM) and SAI JYOTI GRAMODOYOG SAMAJ SEWA SAMITI 417 Gandhi nagar Lalitpur (SAI JYOTI GRAMODOYOG SAMAJ SEWA SAMITI,), individually also "Party" and collectively the "Parties", enter into the following Memorandum of Understanding ("MoU").

1. Forms of Co-operation

Within such fields as are mutually acceptable for the Parties, the following forms of co-operation, amongst others, may be pursued here under:

- Dalit Upliftmen Human Rights, Labour & Employment
- Disaster Management, Drinking Water
- Right to Information & Advocacy, Rural Development & Poverty Alleviation
- Visits by, scholars, teachers and other staff

2. Specific Co-operation Projects

Specific co-operation projects, for instance within such fields as described in section 1 above, must be negotiated separately between the Parties and are in each specific case to be established in separate written agreements, stating the respective rights and obligations of the Parties. In case of any ambiguity or conflict of terms between the terms and conditions of this MoU and those of a separate agreement as mentioned above, the terms and conditions of such separate agreement shall prevail.

3. Financial Arrangements

Both Parties understand that all financial arrangements between the Parties have to be further negotiated and mutually agreed, and will depend on the availability of funds. Both parties may seek financing of joint activities from internal and external sources available to them.

4. General Coordinators

Each Party shall designate an administrative office to oversee and facilitate the implementation of any agreements arising out of this MoU. These offices are:


5. Periodic Review

Both parties agree on the Construe of a four-member monitoring committee for preparing reports & yearly Assessment of planned activities.

7. Legal Relationship

This MoU shall be construed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the Parties. Nothing in this MoU shall create any legal relationship between the Parties.

8. Commencement, Renewal, Termination

This MoU will be effective from the date of the last signature hereto and will remain in force for a time period of five (5) years, with a possibility for renewal at the end of the five-year-period, subject to the Parties' written agreement. Either Party may terminate this MoU by giving six (6) months' notice in writing to the other Party.
